## Terms and Conditions

These terms and conditions apply to all players registered with Leek Wootton Football Club (LWFC) as well as any prospective players who take part in any footballing activity of the club.

By completing this registration process, you are giving permission for your child to participate in LWFC activities and events and agree that you and your child will comply with these terms and conditions:

1. You agree to the club holding the personal information you have provided, including any necessary health, medical or medication data, to ensure your child can take part safely when taking part in club activities. Keeping this information up to date is your responsibility and can be updated anytime online via your child's account. It is also your responsibility to ensure that the managers and coaches of your child's team are aware of any changes to this information throughout the season.
2. You agree to pay fees due to the club subject to such fees having been previously notified to you by the club. You acknowledge that your child attending activities after fees have been notified to you shall be acceptance of your liability to pay such fees.

3. You consent to LWFC registering your child with the relevant football league and Birmingham County Football Association and agree you are liable to pay any fines awarded against your child by such football league or FA.
4. We may send you emails, including the promotion of club events and activities, from LWFC to the email address supplied during registration. Personal data used during the registration process will not be shared with third parties and will remain in line with the Club Privacy Notice which can be found here: [LWFC Privacy Notice](#)
5. You consent to a club representative, or similar, providing basic first aid and lifesaving aid to your child where necessary and in circumstances where the club is unable to contact you or your nominated emergency contact, you agree that a club representative may take your child to hospital and give consent for emergency treatment.
